<p>Course abstract</p> <p>Aims:</p> <p>The Logic of Social Science Research is a compulsory course for doctoral candidates at the Institute of International Relations and Political Science. It aims to introduce the fundamental epistemological, ontological and methodological debates in the social sciences. The course consists of five thematic modules: 1) Philosophy of the Social Sciences; 2) Conceptualisation, Operationalisation and Measurement of Concepts; 3) Analysis of Concepts of Causality; 4) Interpretative Analysis and 5) Principles of Normative Analysis/Theory.</p> <p>Assessment form and evaluation:</p> <ul style="list-style-type: none"> • Attendance and participation in all seminars (9 sessions in total) • Completion of assignments <p>The final grade for the course will consist of the average of the grades of the five thematic modules.</p> <p>Topics of the sessions</p> <p>I. II. Concepts

Course coordinator: Assoc. Prof. Žilvinas Martinaitis

In-person sessions: 1 seminar (2 hours)

Topics covered: We construct explanations of the social world using theoretically based concepts, but to test theories we need to rely on empirically observable implications of phenomena. To what extent is it meaningful and feasible to combine work on these two "fronts"? This module addresses the issues of conceptualising, operationalising and measuring phenomena.

 - What are the challenges in trying to link the theory with the empirical part? What do we see when we look through our theoretical lenses: the world or the lenses themselves?
 - What are the conceptualisation and measurement strategies? What are their advantages and disadvantages?
- Post-seminar written assignment:
 - Choose one widely used concept (e.g., globalisation, quality of studies; these are just examples – choose your own concept based on the topic of your thesis).
 - Provide a definition, conceptualisation and operationalisation of the concept.

III. Analysis of Causality

Course coordinator: Assoc. Prof. Inga Vinogradnaitė and Assoc. Prof. Žilvinas Martinaitis

In-person sessions: 2 seminars (4 hours)

Topics covered: "Correlation does not imply causation" is probably one of the most hackneyed sayings. But what is causality? In this section, we will discuss the concepts of causality and how it relates to empirical data collection strategies and data analysis methods.
